TREASURER'S REPORT

Treasurer RE Bill Hughes presented a report on the Synod's financial results as of December 31, 2019. The report is provided in Attachment 1. He reported that actual expenses were below budget

in most of the categories and per capita collections were higher than projected. One of the reports shows the positive impact that the performance of the financial markets has had on the Synod's major investment accounts. As one example, the Wilshire Properties Fund had beginning balance last year of \$4.510 million and an ending balance of \$5.242 million. This was after withdrawals totaling \$275,000 for the 2019 budget draw and \$31,257 in management fees. Similarly, the value of the Church Development Fund increased by about \$442,000 even through grants totaling about \$239,000 were awarded during the year.

MissionInsite Funding Proposal

Backgound: For the last three years the Synod has contracted with MissionInsite to allow the Synod's presbyteries to have access to the company's software packages at a annual cost of \$10,496. These programs provide their staffs and churches with demographic data on the surrounding neighborhoods that can valuable in planning new church developments and church redevelopements.

The contract is up for renewal for the 2020-2023 period. MissionInsite has proposed a new three-year agreement at a cost of \$8,979 per year which includes a 15% discount based upon the number of churches in each presbytery. A poll of the presbytery executives indicated that there was still interest in having this service available. A copy of the contract is included in Attachment 2.

There was some concerns raised about the number of churches that were used in determing the pricing particularly with one presbytery where the number was higher than it should be. It was agreed that the presbyteries would review the number of churches used for the price quote. Mark Hong will go back to the company and see if they would offer a price reduction based upon a lower number of churches.

It was VOTED to approve a three-year contract (2020-2022) at a cost of up to \$10,000 per year with the funds drawn from the Church Development Fund.

As there was no new business, the Moderator asked RE Pat Niles to close the meeting with prayer and the meeting was adjourned at 10:20 a.m.

CLIENT agrees to appoint a staff person/s to fulfill the role of Administrative User (admin. user). MISSIONSINSITE shall not, during or at any time following termination of this Agreement with CLIENT, disclose or divulge any information provided by the CLIENT to MISSIONINSITE.

CLIENT does agree to allow MISSIONINSITE to use some elements of the final product for the purposes of demonstration. At no time shall MISSIONINSITE divulge any data about particular congregants to which it has access. SCHEDULE A: WEB ACCESS POLICIES

Access to the MI System is at the center of the services provided to CLIENT. Therefore, the following policies should be followed.

Only authorized persons employed by or representing the CLIENT may be granted access. Granting access to any other party is a violation of this AGREEMENT.

No person granted access rights may access and use any part of the site except in the conduct of CLIENT business. Use of any information on other than for CLIENT business is a violation of this AGREEMENT.

The CLIENT Access area on the MISSIONINSITE web site is password protected. Access will be granted according to those given access by the agency administrative user. These can be set up via the Agency Admin. user interface.

There is no limit on the number of users granted to CLIENT. However, only the CLIENT may authorize users and MISSIONINSITE will only add users upon the formal request of the authorized agent of the CLIENT. Unless otherwise stipulated, the authorized agent is the person signing the AGREEMENT.

SCHEDULE B: DATA SECURITY

Data in Transit

1.A – Web Transfer Security

Data actively moving from an external system to the MissionInsite system is required to be transmitted over a secure channel. In the case of web transfers, this means all communications to the MissionInsite Maps System are conducted over SSL/TLS. SSL/TLS is required and enforced both by the MissionInsite web servers and the Maps web system.

1.B - FTP Transfer Security

FTP communications are conducted over SFTP (SSH over FTP) which requires both a username/password combination and a client certificate. When data is provided over SFTP, it is removed from the FTP server upon receipt and moved to a secure storage location which utilizes a secure SSL/TLS tunnel for transfer.

1.C - Network Security

Firewall, IDS and other boundary services are placed to control communications at external network boundaries which enforce ACLs (Access Control Policies) to manage traffic flow. Secure access points (limited in number) comprehensively monitor inbound and outbound communications. A wide variety of automated monitoring systems designed to detect unusual or unauthorized intrusion attempts (including DDos, MITM, IP Spoofing, Port Scanning and Packet Sniffing) are employed at each access point.

Any data provided is immediately loaded into a MissionInsite relational data store or moved directly to the MissionInsite secure data store. At such time are subject to all security protocols outlined below (see *Data at Rest*).

Data at Rest

2.A - Network Security

Data that is not actively moving to or from the MissionInsite system is housed centrally on an AWS (Amazon Web Services) virtual server. As such natively benefits from AWS' Global Security Policy which provides facility/hardware level security (see 1.C – Network Security).

2.B – Access Control

Access controls to MissionInsite data systems are managed internally by MissionInsite and tightly limited in terms of administrative access. Non-technical staff have access (via the MissionInsite Maps web system) only to what is specifically granted by the MissionInsite Network Security team and have no direct access to the underlying data system. The data system logs authentication failures and those logs are routinely reviewed by the MissionInsite Network Security Staff. Non-relational data is subject to similar access control restrictions and is encrypted at all times.

2.C - Data System Encryption

MissionInsite data systems all employ "Always Encrypted" technology that transparently and automatically encrypts all sensitive data. This encryption is applied on the fly and makes sensitive data unintelligible to all other systems (including itself) that have not been explicitly granted a decryption key (such as the MissionInsite Maps System).

2.D – Data Backup Encryption

Data system backups are fully encrypted during the backup process and (in all but limited scenarios) immediately moved off-system to secure AWS storage.

2.E - Non-Relational Data

All MissionInsite non-relational data (e.g. documents, spreadsheets, etc.) are encrypted using a 256-bit AES algorithm while at rest and subject to company-wide access control restrictions.



The Committee recommends that the Commission elect the following candidates for current vacancies:

The Chair called for nominations from the floor. Hearing none, the the Chair called for a vote and these two people were elected.

Recommendation for Action

The Committee recommends that CRE Mickey Fenn (Santa Barbara) and CRE Ruth Mandenach (San Fernando) be nominated and elected by the Commission of Assembly to the Committee on Representation and Nominations, Class of 2022. There are additional vacancies, including a representative from San Diego. CoRN members are nominated by CoA and elected by the Synod, not by CoRN.

A motion was made, seconded and passed to nominate CRE Mickey Fenn and CRE Ruth Mandenach to the Committee on Representation and Nominations.

The following items was reported for information

Request Sent to Committees and Workgroups The Committee requested that Commission of Assembly Committees (as approved in October 2019) organize themselves by confirming current members and assigning them to classes for 2020, 2021, and 2022 by seniority. The attached memo was sent to the committees on March 12, 2020, with the request that information be returned by April 30, 2020. With this information, the Committee will identify and attempt to fill vacancies.

Resignation

CoA Member RE Elizabeth Hicks (PA) has submitted a letter of

resignation due to the need to cut back some of her commitments. Her resignation was accepted by the CoA at its February 15 meeting.

Additional Vacancies to be Filled

There was discussion that additional members are needed on the Committee on Representation and Nominations. Pat Niles and Frances Lin suggested several names and offered to follow up with those persons.

Synod Assembly Date Change

The Stated Clerk reported that date of the Synod Assembly has been moved to <u>Saturday</u>, <u>December 5</u> from Saturday, November 14 due to a conflict with another meeting scheduled for November 14. The Assembly has been invited to meet at the Monte Vista Presbyterian Church in Newbury Park, a member of the Santa Barbara Presbytery.

POLITY AND RECORDS COMMITTEE REPORT The minutes of their meeting of March 19 were distributed as a part of the reports for this meeting of the Commission of Assembly.

Committee Chair, RE Martha Kadue, reported for the committee.

The committee had been asked to review two overtures to the General Assembly and make recommendations to the Commission of Assembly as to whether or not the Synod should concur with those overtures.

Overture on Benefits for Mid-Council Executive Staff

The first is the Overture on Benefits for Mid-Council Executive Staff proposed by John Calvin Presbytery. Changes made to the Board of Pensions menu of benefits in 2017 has given rise to the inequity in cost of benefits between ruling elder staff and teaching elder staff. The committee members generally found unacceptable the inequity in cost that placed the employing presbyteries and synods in a difficult position of incurring additional benefit costs or taking ordination into account in hiring decisions, or potentially depriving ruling elder employees of equal benefits.

Recommendation #1

The Committee recommends that the Commission of Assembly concur on the overture on Benefits for Mid-Council Executive Staff proposed by John Calvin Presbytery.

It was VOTED to concur with this overture with one abstention. TE Claassen abstained since it would be reviewed first by the Advisory Committee on the Constitution the overture, of which he is member.

Overture on Creating a Task Force on Creating a Korean-Language Nongeographic Presbytery on the The second is the <u>Overture on Creating a Task Force on Creating a Korean-Language Nongeographic Presbytery on the West Coast proposed by the Northwest Coast Presbytery.</u>

California) or that currently exist (one in the Southeast, one in the Chicago area, and one in the East Coast area). He also noted the reasons that this Synod asked General Assembly to dissolve Hamni Presbytery, and that the Korean-language churches have largely successfully assimilated into the stable and harmonious church governance of their geographic presbyteries.

Recommendation #2

The Committee recommends that the Commission of Assembly not concur in the Overture and that Synod take a position opposing the overture at General Assembly.

After discussion, a motion was made, seconded and VOTED to postpone this item indefinitely.

GRANTS TO THE PRESBYTERIES

During the last two weeks, the presbytery executives had been talking with Mark Hong about the possibility of the Synod providing funds to the help the presbyteries in aiding their churches during this pandemic period. Several of the presbyteries have already allocated some of their own funds for this purpose.

There was discussion about the amount of the presbytery grants, the source of the funds, and the procedures needed to access the funds. There was considerable discussion concerning these items. An initial motion was made, seconded an amended several times.

The final motion presented was as follows:

That the Synod of Southern California and Hawaii make available \$150,000 per presbytery for use within calendar year 2020 to address critical financial needs within the presbytery arising from the COVID-19 pandemic. The Synod would disburse the funds upon written request of the Executive Presbyter or Stated Clerk.

The motion was passed. The Synod and Synod Treasurer would determine which account(s) will be tapped for these funds as needed.

There was also discussion about an offering a "jubilee year" that would not require churches and presbyteries to pay Synod per capita. The Commission decided to take no action on this item.

OTHER BUSINESS

TE Mark Hong reported that at this time GA Commissioner Orientation will still take place on Saturday, April 25. The session will take place entirely via Zoom.

NOVID-19 Concerns

Prayers were requested for several persons in the presbyteries having problems related to the COVID-19 virus.
