REPORT OF THE SYNOD EXECUTIVE

Mark Hong presented a written report that is presented here

First of all, I welcome back Rev. Juan Sarmiento as he begins his service as the Executive Presbyter for San Fernando. I look forward to working with him along with other Presbytery leaders.

As Fried Wilson's service to the Synod is nearing an end, the Personnel Committee has been diligently working to find his successor. The committee has decided on the candidate and will make the recommendation later in this meeting.

The work of the Synod is ongoing, although most are accomplished from our homes. I along with the staff have been coming into the office as needed, but most of my work is done via Zoom and other means at home. I believe I have gone through hundreds of Zoom meetings since the Pandemic started with the folks in the Synod bounds as well as with the folks beyond.

I am a part of an executive group that is preparing for the gathering of Mid Council Leaders (both Presbyters and Stated Clerks), which will take place at the beginning of 2021. I am currently serving as the treasurer for the Association of Stated Clerks, which is a two-year service.

I would like to thank Michael Mudgett for leading the folks from San Diego to send in their appreciation for the Synod fund. I have received numerous cards and emails sharing their deep sense of gratitude to the Synod, reaffirming our sense of a connected church. We have completed distributing \$150,000 to each of our seven Presbyteries.

The PCCCI's effort to sell Rancho La Scherpa to Hope Refuge is almost at the finishing line. Hope Refuge is working to finalize the escrow at the end of the year.

The board's effort to manage the current situation at Zephyr Point continues. During its recent board meeting held on September 27-29, it voted to create a Special Task Force (2 Synod Execs and 3 others) to study financial outlook as well as reviewing its article to clarify the Synods' ownership of Zephyr Point.

PERSONNEL COMMITTEE REPORT CoA Chair TE Joshua Yee asked RE Pat Niles to moderate the meeting so he could present the Personnel Committee Report. An edited version of the report is provided below.

Over the last couple of months, CoA Personnel Committee convened via Zoom on the following dates: June, 10; July 9, 18; August 1; September 5, 11, 19, to complete the following tasks: finalize the revised job description for Business Manager as we prepare for finding a replacement for Fried Wilson, who will be retiring at the end of 2020; discuss salary range for Business Manager; determine interview and hiring process of Business Manager; interview and hire a new Business Manager; hold annual reviews for current Synod staff (Mark Hong: Stated Clerk and Synod Executive; and Joanne Bortfeld: Bookkeeper); and discuss salaries for FY21.

Personnel Committee sent out a survey to the Presbytery Executives and the Stated Clerks of the Presbyteries without an Executive as a part of Mark Hong's annual review. The feedback was overwhelmingly positive and supportive of him being in this role.

On September 19, we held annual reviews via Zoom with both Joanne and Mark. Both are pleased with their work this past year, especially

amidst the pandemic and needing to be creative and flexible during this time.

On September 25, the Personnel Committee met in person at the Synod office and held 2nd level interviews with our top two candidates for the Business Manager position. After extensive interviews with both candidates, the committee voted unanimously to offer the position to Paula Mann the position of Business Manager on September 28 via email. Paula's first day will begin on November 1, 2020 and will include training time with Fried over the next two months.

On September 25, the Personnel Committee made a recommendation (3 votes for and 1 vote against) to give a 2% COLA (cost of living adjustment) to our current staff members (Stated Clerk and Synod Executive, Bookkeeper, and REPL coordinator) excluding the position of Business Manager since this will be a new person in the role as of November 1.

The committee report recommended and the Commission approved a cost of living raise for the staff of 2%. This will appear in the proposed 2021 budget that will be discussed later in the meeting.

Joshua then resumed the chair as moderator.

REPORT OF THE SYNOD TREASURER Treasurer RE Bill Hughes first presented the financial review for 2019 that was sent to the members with the other materials for this meeting. He reviewed the purpose of a financial review and the reviewer's findings.

A motion was made, seconded and passed to receive the 2019 Financial Review.

This document is made a part of these minutes as Attachment 1.

He then presented the financial report for the period ending September 30, 2020. Expenses are significantly below budget since groups across the denomination have not been meeting in person and the Synod Executive has not been traveling as much as had originally been forecasted. The financial report is included in Attachment 2.

The final presentation was the proposed 2021 budget. This budget was created based upon the assumption was that travel and expenses would be in line with those originally projected for 2020. However, it is not know at this time if the Covid-19 shut down will last

past January 2021. The budget also includes the change in staffing for 2021 and a 2% cost of living increase for the staff.

A motion was made, seconded and passed to recommend that the Synod Assembly approve the proposed 2021 budget.

The proposed budget is included as Attachment 3.

REPORT FROM THE COMMITTEE ON REPRESENTATION AND NOMINATIONS CoRN Co-chair TE Wendy Tajima presented a written report from the committee which included two action items, one recommendation, and one item for information.

A motion was made, seconded and passed to nominate RE Frances Lin to the Committee on Representation and Nominations for election by the Synod Assembly.

For information

The Committee has done an excellent job of organizing members of task forces into classes, and reviewing the needs of the Synod and possibilities for continuing and new leadership. A list of current members and the slate of nominees as currently confirmed was provided.

PARTNERING GRANTS WORK GROUP RE Sue Curry, member of the work group reported for the chair TE Linda Culbertson who had provided the following written report.

The Partnering Grants Work Group met on Wednesday, October 7, 2020. Members present were Linda Culbertson, David Won, Sue Currie, and Ken Baker. Excused was N'Yisrela Watts-Afriyie.

For Action:

The Partnering Grants Work Group recommends that the Commission of the Assembly approve a matching grant of \$24,000 to San Gabriel Presbytery, out of its allocation of Congregational Partnering Grants, to match first-year funding in support of a new worshipping community in the Rowland Heights community.

It was VOTED to approve the matching Partnering Grant to San Gabriel Presbytery for its new worshipping community in Rowland Heights. The full application is included as Attachment 4

ASYLUM HOSPITALITY GRANT APPLICATION The Presbyteries of the Pacific, Riverside, and San Gabriel request a \$30,000 grant from the Synod of Southern California and Hawaii for support of the Southern California Immigrant Accompaniment Ministry, a coordinated, multi-faceted program of church support and training, direct service and hospitality, and interfaith advocacy as we live out the Gospel by caring for people seeking refuge in the United States. Specifically, we seek support for this growing network of presbyteries, churches and individuals, and partner service organizations who organize to provide support to people fleeing violence and persecution in their home countries as they await immigration court appearances in Southern California.

The full application is included as a part of these minutes in Attachment 4.

A motion was made, seconded and passed to approve this grant in the amount of \$30,000 with the funds to be taken from the Synod's Unrestricted Reserve Account. Further information will be provided as to how the funds are to be paid to the three presbyteries.

GRANT REQUEST FROM POP FOOD BANK MINISTRIES This grant request came from a coalition of churches in the Presbytery of the Pacific with food ministries. This coalition has provided food for around 250,000 people from five presbyteries within the boundaries of the Synod of Southern California and Hawaii since the beginning of the pandemic. These coalition churches have invested heavily in meeting the need of their community by reallocating staff resources, redirecting reserve funds, refocusing budget, and reimagining vision of being the presence of God's people in their community.

The coalition is asking for \$75,000 from the Synod of Southern California and Hawaii to purchase a truck. The coalition has secured \$75,000 from the Presbytery of the Pacific, \$25,000 from the Presbyterian Disaster Assistance, and have raised about \$10,000

through various fundraising events to support these food ministries. They are also seeking grants from other non-profit foundations.

More details including a three-year budget can be found in their application which is included as a part of these minutes in Attachment 4.

After much discussion, a motion was made, seconded and passed to refer this request to refer this grant request to the Restricted Funds Work Group for their review and empower the group to make the final decision.

As a part of their review, they are to ascertain that it has the support of at least one presbytery.

SYNOD ASSEMBLY

The Synod Assembly has been scheduled for December 5 at Monte Vista Presbyterian Church in Newbury Park (Santa Barbara Presbytery). Given the COVID-19 pandemic and shut-down, it is unlikely that the assembly can be physically held there. A motion was made, seconded and passed to hold the assembly via Zoom.com.

The Executive/Stated Clerk will work with the pastor of the church to determine the church's role in the assembly.

REQUEST FROM MONTE VISTA GROVE HOMES

The Board of Monte Vista Grove has requested that the Synod of Southern California and Hawaii approve the following change to its Bylaws (Article VI – Trustees) as a related Entity of the Synod and confirm the election of Trustees.

A motion was made, seconded and passed to approve the change in the MGVH Bylaws and to confirm the election of Trustees as detailed in their report that is included as a part of these minutes as Attachment 5.

FAREWELL

TE Michael Mudgett announced that he will be retiring from his position with the San Diego Presbytery at the end of this year. Commission members wished him well in his new endeavors.
