#### **TREASURER'S REPORT**

Synod Treasurer, RE Bill Hughes presented the financial statements of October 31, 2020. These reports were made available to the commissioners with the other meeting materials. The treasurer lifted up the cash balance and some fund balances. This provides the operating capital for the Synod operations. Assets are close to \$13 million. The Synod is in a good position. Expenses are down due to the pandemic. The financial reports are included as Attachment 1.

#### **REPORT FROM THE PRESBYTERY OF SANTA BARBARA**

TE Janet Loughry reported that COVID-19 had impacted the presbytery. There are weekly Zoom gatherings for pastors and for church finance managers. All presbytery committees are meeting by Zoom. The Synod grant of \$150,000 was shared among churches that requested support. The funds were distributed equally among these churches. Any remaining funds were distributed to new worshiping communities. There is a new worshiping community-the Collection at Oxnard. There are 6 new pastors in the presbytery. She also reported on upcoming events.

# **REPORT OF THE LAC+USC CHAPLAINCY PROGRAM**

TE Elizabeth Gibbs Zehnder, the Presbyterian Chaplain at LAC+USC Medical Center, is supported through the Presbyteries of the Pacific, San Gabriel, San Fernando and Los Ranchos as well as by the Synod of Southern California and Hawaii. She spoke about her work there, and then about how others can become involved this ministry. The service of those who passed from this life to the next but remains were unclaimed was lifted. This includes praying for the ministry and for the people involved with it. The impact of COVID-19 was shared. There is a flyer included as Attachment 3 with information about supporting the ministry of the chaplains.

## **REPORT OF PRESBYTERIAN CAMP AND CONFERENCE CENTERS, INC.**

RE Bob White (chair of PCCCI) presented a brief report on the state of PCCCI, Inc. The Big Bear Center has had one of its best years and the La Scherpa property in Santa Barbara is still being rented to Hope Refuge. The PCCCI Board determined to sell the property to Hope Refuge. The property is in escrow at the time of this meeting. See Attachment 4 for the financial report.

# **REPORT OF THE PRESBYTERY OF THE PACIFIC**

Linda Culbertson, General Presbyter, reported on the Food Ministry activity within the presbytery. The presbytery raised funds through an online concert. There are eleven churches collectively serving about 15,000 households monthly. A truck has been purchased with the assistance of funds from the Synod of Southern California and Hawaii.

# **REPORT OF THE PRESBYTERY OF LOS RANCHOS**

The written report is in Attachment 5. Ruling Elder Anette Rihovsky provided a personal reflection on the impact of the pandemic. This included a report regarding the September meeting of the presbytery which included the Rev. Dr. Dianne Moffit, President and Executive Directive of the Presbyterian Mission Agency, speaking on the Matthew 25 project.

## **REPORT OF THE PRESBYTERY OF RIVERSIDE**

Transitional Presbytery Executive TE Lee Ireland reported about the use of the COVID-19 grant funds. The funds were used for churches to upgrade technology. The presbytery is moving into the immigrant grant from PDA. There are five worshipping communities that are doing well. The presbytery is moving to a discernment process for the presbytery.

# **REPORT OF THE COMMISSION OF ASSEMBLY**

TE Joshua Yee, chair of the Commission of Assembly presented a written report that is in Attachment 7. Commission of Assembly met 5 times. The chair pointed out a few significant items. COA agreed to distribute \$150,000 to each of the seven presbyteries for COVOD related needs. Personnel Committee met several times. Annual reviews were held and received overwhelming positive feedback for staff members. Fried Wilson will be retiring December 31, 2020. The chair recognized Fried's dedication to the Synod. TE Paula Mann (member of Pacific Presbytery) was introduced as the incoming Business Manager. Paula Mann greeted the assembly.

# FOR ACTION

The Commission of Assembly recommended that the Synod Assembly approve the proposed 2021 Synod Budget (Attachment 8)

The major item to note in this budget as compared to the 2020 budget is:

• A 2% cost of living salary increase for staff members.

The Assembly VOTED to APPROVE the 2021 Synod Budgets as presented.

#### **REPORT OF THE PRESBYTERIAN MISSION AGENCY**

RE Rene Myers, Regional Representative, reported on behalf of the Presbyterian Mission Agency. She reported that the PMA is encouraging all congregations and presbyteries to identify as Matthew 25 groups. She said to consider her as an adjunct member of staff. Please consider them as pulpit supply.

#### **REPORT OF ZEPHYR POINT PRESBYTERIAN CONFERENCE CENTER**

Executive Director Dick Young spoke about this facility which is the oldest Presbyterian conference center in the Western part of the United States. This center was started by the former Synod of California and ownership and governance are now shared by the Synod of Southern California and Hawaii and the Synod of the Pacific.

He reported that he has recently been named as the Executive Director. SOSCH provides 1/3 of the board. Thanks to the board members and to the synod for support to Zephyr Point. Thank you for a grant to renovate Dobbins Hall. ZP is working hard during this time of the pandemic. ZP has been closed for conferencing since the end of October. From July through October could only host conferences of fewer than 50 people. It has been a financial challenge. ZP has adopted a new mission statement, vision statement and core values. In conversation with the Association of Presbyterian Colleges (APCU) and Universities to develop a study away program at ZP that would be sponsored by the APCU.

The financial challenges for the coming year may require some support from the synod. Director Young indicated that there may be a need for short term help. The written report is Attachment 6

## **REPORT OF THE PRESBYTERY OF SAN DIEGO**

Executive Presbyter Michael Mudgett reported on 2020 grants received and given. Expressed thanks for the \$150,000 grant from the Synod to help with the pandemic response. He also thanked the Synod for the congregational grants provided. Acknowledged PDA for other grants received. Reported on Nyland that had a fire and the presbytery has donated \$15,000 to support the city. The local congregations are supporting the city. Six candidates for ministry have been approved as was a CRE. San Diego Presbytery is still in transition – 5 churches in transition. This is down from 2 years ago when half the churches were in transition. Cyclicle San Diego is going well planting five new worshipping communities. Michael shared a goodbye as this was his last meeting. Michael McClenahan shared words of thanks for Michael Mudgett's service.

## **REPORT OF THE SOUTHERN CALIFORNIA FORUM**

Joey Baker, Administrative Assistant, provided the report. He thanked the Synod for its support. The Forum is an ecumenical body. The Forum works to connect people across Christian lines. The Forum provides Bible Studies and has thrived using the virtual format that the pandemic has required. The internship program is expanding.

# **REPORT OF RACIAL ETHNIC PASTORAL LEADERSHIP COMMITTEE**

Narcissis Tucker Bishop provided the report. She thanked Fried Wilson for his support when she was in seminary and for other seminary students. A written report is included as Attachment 9. She reported that she is struck by the fact that in 2020 financial support is needed. Narcissus shared the poem, Caged Bird, by Maya Angelou. She commented how much of the task force report written in 1979 still needs to be addressed. Narcissus thanked all who have supported REPL.

## **REPORT OF THE PRESBYTERY OF SAN FERNANDO**

Executive Presbytery Juan Sarmiento provided the report. A written report is provided as Attachment 10. Juan has served in the past in the Synod and is glad to have returned to his new position as EP. He thanked the San Fernando Presbytery for providing grants to local congregations. The presbytery has 2 new worshipping communities which brings the total to about the same number as congregations. Juan concluded by inviting all to a conference in March 2021. Alan Hirsh will be one of the speakers.

# **REPORT OF THE PRESBYTERY OF SAN GABRIEL**

EP Wendy Tajima thanked the synod for the grants received. The presbytery provided about \$300,000 in grants during 2020 using synod and presbytery funds. She discussed the emergency grants from PDA that helped recent immigrant congregations. Wendy also shared a brief update regarding Kristy Van Nostran's work of transitioning people to safe homes and sponsors. Wendy shared a brief video showing the life 'in' the churches during this pandemic.

## **REPORT OF THE JUSTICE, PEACE, AND INTEGRITY OF CREATION (JPIC)** COMMITTEE

Darrel Meyers provided a report (written report is Attachment 11). The committee met three times in 2020. No grants were given this year. Two topics of special concern were generally before the committee; 1 - the shape of the planet, 2 - focus on Israel and Palestine.

## **REPORT OF MONTE VISTA GROVE HOMES**

RE Fried Wilson reported. After providing a brief history of MVGH, he shared an update on the current state of the pandemic's impact. A written report (the Fall 2020 Messenger issue) is Attachment 13. MVGH is dependent on gifts to continue its ministry.

# **REPORT OF THE SYNOD EXECUTIVE**

TE Mark Hong referenced the GA Stated Clerk's video and the work the church has accomplished. He reported that our presbyteries continue their work during the pandemic. He also commented that the Synod of Southern California and Hawaii is able to provide grants and is proud to be able to do so. The written report is Attachment 12.

# CLOSING WORSHIP AND INSTALLATION SERVICE

In the closing worship service, the 2021 Synod Commission of Assembly Chair, RE Pat Niles, the 2021 Synod Moderator, TE Suzanne Malloy, and the 2021 Synod Vice-Moderator RE Janine Tanahuvia, were installed by the outgoing Commission of Assembly Chair, TE Joshua Yee.

## ADJOURNMENT

The Assembly was adjourned with prayer following the worship service at 12:37 p.m.

The Committee on Representation and Nominations has met multiple times throughout the year to discern leadership for the Synod. The Committee also reorganized several working groups that were regulated by the October 2019 Standing Rules of the Commission of Assembly.

# **For Action**

- 7. The Committee on Representation and Nominations recommends that the Assembly confirm the following succession as provided in the Synod's Bylaws:

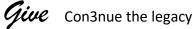

#### 1. Organization and Operations:

#### **Organization Activities**

Presbyterian Camp and Conference Centers, Inc. (PCCCI) was formed in October 2004 and began operations on April 1, 2005. PCCCI was formed by the Synod of Southern California and Hawaii, which is a governing body of the Presbyterian Church, USA (PCUSA). The synod consists of all the churches and ministers within a specified geographical district, organized for the purpose of facilitating the management of the religious, hospital and charitable activities of the PCUSA. PCCCI owns and operates two camp and conference centers located in Southern California which were formerly owned by the Synod. PCCCI assists in furthering the purposes of the PCUSA by providing retreat facilities and programmed camping to churches and religious organizations.

#### 2. Significant Accounting Policies:

The following significant accounting policies of the Presbyterian Camp and Conference Centers, Inc. are used in the preparation of these financial statements.

#### Fund Accounting

The accounts of the organization are maintained in accordance with the principles of fund accounting. This is the procedure by which resources are classified for accounting and reporting into funds established according to their nature and purpose.

The organization has adopted FASB ASC 958-605, "Accounting for Contributions Received and Made", FASB ASC 958-205, "Financial Statements of Not-for-Profit Organizations: and FASB ASC 958-320, "Accounting for Certain Investments Held by Not-for-Profit Organizations." FASB ASC 958-320 requires that covered investments be reported in the statement of financial position at fair value with any realized gain and losses reported in the statement of activities and any unrealized gain and losses (the difference between cost and fair value) reported as a separate component of Net Assets on the statement of financial position.

#### 2. Significant Accounting Policies, continued:

FASB ASC 958-205 establishes standards for external financial reporting by not-for-profit organizations and requires resources be classified for accounting and reporting purposes into net assets categories according to externally (donor) imposed restrictions. FASB ASC 958-605 requires that unconditional promises to give be recorded as receivables and revenues and requires the organization to distinguish between contributions received for each net asset category in accordance with donor-imposed restrictions. The assets, liabilities and net assets of the organization are reported within categories as follows:

#### Net Assets

"Unrestricted Net Assets" - the part of the net assets of the organization that is not temporarily restricted by donor-imposed stipulations - that is, the part of net assets resulting from (a) all revenues, expenses, gains, and losses that are not changes in temporarily restricted net assets and (b) reclassifications from (to) other classes of net assets as a consequence of donor-imposed stipulations, their expiration by passage of time, or fulfillment and removal by actions of the organization pursuant to those stipulations. The only limits on unrestricted net assets are broad limits resulting from the nature of the organization and the purposes specified in its articles of incorporation or bylaws and, perhaps, limits resulting from contractual agreements.

"Temporarily Restricted Net Assets" - the part of the net assets of the organization resulting from (a) contributions and other inflows of assets whose use by the organization can be fulfilled and removed by actions of the organization pursuant to those stipulations, (b) other asset enhancements and diminishments subject to the same kinds of stipulations, and (c) reclassifications to (from) other classes of net assets as a consequence of donor-imposed stipulations, their expiration by passage of time, or their fulfillment and removal by actions of the organization pursuant to those stipulations.

"Permanently Restricted Net Assets" - the part of the net assets of the organization resulting from donor-imposed restrictions that will not expire by the passage of time and cannot be removed by actions of the Board of Trustees.

#### 2. Significant Accounting Policies, continued:

#### Income Taxes

Presbyterian Camp and Conference Centers, Inc. is exempt from Federal income and California franchise taxes under the provisions of the Internal Revenue Code Section 501(c)(3) and corresponding California provisions. Accordingly, no provision has been made for such taxes in the accompanying financial statements. As a result of their tax-exempt status, there are no uncertain tax positions required to be reported in accordance with FIN48.

#### Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statement and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

#### Property and Equipment

It is Presbyterian Camp and Conference Centers, Inc. policy to capitalize property, furnishings, equipment, and leasehold improvements over \$1,200. Lesser amounts are expensed. Building, improvements, furnishings, and equipment are capitalized at cost or fair market value at date of donation. Depreciation is computed using the straight-line method over the estimated useful lives of the assets which are as follows:

#### Guest Group Deposits

Guest Group deposits consist of deposits made for upcoming stays at the Big Bear Lake Christian Conference Center. Guest Group deposits are recognized as revenue at the opening date of each groups stay.

#### 4. Investments, continued:

**Level 2:** "Level 2 inputs are inputs other than quoted prices included within Level 1 that are observable for the asset, either directly or indirectly." Examples of Level 2 inputs include the following: quoted prices for similar assets in active markets or in markets that that are not active and inputs other than quoted prices that are observable for the asset.

**Level 3:** "Level 3 inputs are unobservable inputs for the asset. Unobservable inputs shall be used to measure fair value to the extent that observable inputs are not available, thereby allowing for situations in which there is little, if any, market activity for the asset at the measurement date."

Investments are carried at fair value based on the net asset value of the underlying mutual funds as of the balance sheet date.

#### 5. Employee Benefits:

Regular full-time employees, excluding the Executive Director, are provided with group health insurance. PCCCI will pay 50% of each eligible employee's health insurance premium under the plan. The employee is responsible for the remaining 50% of the premium through payroll deductions.

Retirement benefits are provided to regular full-time employees, excluding the Executive Director, who establish a 403(b) account. PCCCI will match the employee's contribution up to 6% of the employee's salary. For the year ending December 31, 2019 there were no salary deferrals or matching contributions.

Under the terms of the Executive Director's employment agreement, PCCCI will pay 100% of the health insurance premiums for the Executive Director and his family. PCCCI also agreed to pay retirement benefits of 6% of the Executive Director's salary and will match pension contributions up to 6% of the Executive Director's salary. For the year ended December 31, 2019, PCCCI's pension contribution expense was \$8,986.

#### 6. Concentration of Credit Risk:

The organization maintains cash and investments in New Covenant Funds. These cash and investments are not insured. At December 31, 2019, the organization's uninsured cash and investments balance total \$1,058,928.

The organization maintains cash balances in Union Bank of California. Cash balances are insured to a maximum of \$250,000 through the FDIC. The organization has no uninsured cash balances at Union Bank of California at December 31, 2019.

#### 7. Endowment Fund Restrictions:

Endowment funds (fair market value of \$64,127 at December 31, 2019) originally transferred from the Synod of Southern California and Hawaii have been classified as permanently restricted. These funds were donated many years ago to the Synod of Southern California and Hawaii for the direct benefit of the retreat centers. Currently, it is unclear what amount is in fact permanently restricted. Until such time the correct amount can be determined, the Endowment Fund is considered permanently restricted.

#### 8. Legal Matters:

Presbyterian Camp and Conference Centers, Inc. has received pre-litigation claims and is named as a defendant in multiple lawsuits claiming reimbursement for property damage, loss of business income, personal injuries, payments made to insureds, and/or expenses incurred caused by the Sherpa Fire, a wildfire in Santa Barbara County, occurring in June and July of 2016 and alleged flooding resulting therefrom which occurred in January 2017. Presbyterian Camp and Conference Centers, Inc. is contesting these matters. The combined amounts being demanded by parties associated with current or anticipated filings alleging damages caused by the Sherpa Fire currently exceeds the limits of Presbyterian Camp and Conference Centers, Inc's liability insurance by at least \$2 million to \$3 million. There is also a potential for additional subrogation claims to be filed in the future which would significantly increase this uninsured exposure. While management believes there is a risk of an unfavorable outcome at this time in these matters, management is not able to reasonably estimate the amount of the loss. Accordingly, no accrual has been made in the financial statements for the ultimate resolution of these legal matters.

#### 9. Commitments and Contingencies:

Under the rules of the denomination, all property of the Presbyterian Camp and Conference Centers, Inc. is held in trust for the use and benefit of the Presbyterian Church (USA). In the event that the Presbyterian Camp and Conference Centers, Inc. was to leave the denomination or certain related events were to occur, the control of the property of the Presbyterian Camp and Conference Centers, Inc. and the satisfaction of related debts would become the responsibility of the Synod of Southern California and Hawaii.

#### **10.** Subsequent Events:

Presbyterian Camp and Conference Centers, Inc. has evaluated events subsequent to December 31, 2019 through the date these statements were available to be issued. There have been no subsequent events that have occurred during the period that would require recognition in the financial statements or its disclosure for 2019.

Presbytery of Los Ranchos, Annual Report December 5, 2020

"God calls the Presbytery of Los Ranchos to cultivate vital congregations and partnerships that embody the love and justice of Jesus Christ." (Mission Statement)

2020 began for Los Ranchos with heightened enthusiasm for engaging PMA's Vital Congregations Initiative as a "Second-Wave Presbytery." Plans were made for over twenty leaders to attend the National Gathering in Austin. Then COVID-19 struck.

In March, the focus of presbytery's leadership turned toward supporting congregations to help them survive the immediate challenges precipitated by the pandemic. We used every media possible (website, E-News, Face Book, and on-line forums) to help pastors and elders keep their communities together and rowing in the same direction.

Our co-executives started weekly Zoom chats in which as many as twenty-five teaching elders gathered to share their struggles and ideas about ministering in a rapidly changing context. Congregations with a history of broadcasting via TV and online were instrumental in guiding those who had no previous experience with these media. The hardships of the pandemic prompted leaders to share resources with each other in an unprecedented way, which was itself a beautiful witness to the unity Christ desires for the Church. With the help of a generous gift from the Synod, Council and its teams initiated a presbytery-wide COVID-19 Emergency Grant program to support hurting churches, thanks to the Synod's generosity and the good management of existing PLR resources.

Simultaneous with the work above was a presbytery-wide effort to interrupt systemic racism, first by learning more about the societal forces that privilege white people over people of color and later to begin examining how those same forces were at work in our presbytery. A twenty-seven-member AC that was originally commissioned in May "to enact decisions necessary to ensure the financial stability of the Presbytery" and to "bring concrete recommendations…for the reorganization of the Presbytery" instead brought a recommendation in September "to address the power imbalance that preferences larger, predominantly Caucasian congregations… and to address the church's role in dismantling systemic racism in the presbytery's culture." Los Ranchos is working hard to examine its own complicity in systemic racism and to make the changes necessary to become a more inclusive and equitable community for all its members.

Another effort Los Ranchos has made to be faithful to our mission is to prune strategies and activities that were once bearing fruit, or at least great promise, during "normal times," but which no longer hold the same promise during this time.

One example of this pruning was Council's decision in late summer to suspend PLR's relationship with Cyclical, Inc. so that we could reinvest our church-starting resources in new ways. Beginning in 2021, we will offer a year-long training process with monthly webinars called "Missional Leader and Pioneer Training" designed to help discerners and church planters launch new worshiping communities or re-launch congregations that need a fresh way to engage their neighbors.

Under difficult and unprecedented circumstances, Los Ranchos is rising to the challenge of 2020 by keeping faith with each other and making the changes required to embody the love and justice of Jesus Christ. Words are unable to express the gratitude we feel for the way our Synod and denomination has accompanied us this year. We give thanks for the seemingly endless resources of prayer, wisdom, strategies, and encouragement that have been so generously given. Thank you for your faithful partnership in this noble and worthy work, to the glory of God.

#### Synod of Southern CA and Hawaii Commission of Assembly Report December 5, 2020

Commission of Assembly met on the following dates via Zoom: February 15, March 28, June 6, and October 10. Along with holding normal business at each of our CoA meetings, I would like to highlight the following:

- Due to the extreme strain that COVID-19 has had on many of our churches, CoA agreed to distribute \$150,000 to all 7 Presbyteries, which would then be distributed among the local churches within each Presbytery as requested. This was very well received by the Presbyteries as well as the individual church recipients of this financial aid.
- CoA hired a new Business Manager, Paula Mann, as a replacement for Fried Wilson, who is retiring at the end of 2020. Paula rose to the top of our candidate pool and she accepted the position on September 28. Paula's start date as the new Business Manager was on November 2 and she has since been working with Fried and Mark to acclimate and transition in this new role.
- CoA personnel committee held annual reviews for the current Synod staff (Mark Hong as Stated Clerk and Synod Executive; and Joanne Bortfeld as Bookkeeper). There was also a survey that was sent out to the Presbytery Executives and the Stated Clerks of the Presbyteries (for the Presbyteries without an Executive) as a part of Mark Hong's annual review. The feedback for Mark was overwhelmingly positive and unanimously supportive of him serving in this role as both Synod Exec and Stated Clerk. CoA personnel committee was pleased with the staff's ability to adapt to the unique and challenging circumstances of this year. The committee expressed gratitude and appreciation for the good work that has been done by the staff throughout this year.
- CoA voted to approve a 2% salary increase for cost of living adjustment for 2021 to our current staff (Stated Clerk and Synod Executive, Bookkeeper, and REPL coordinator), excluding the position of Business Manager since this position is being filled with a new individual in the role as of November 1.

## Synod of Southern California and Hawaii (PCUSA) Racial Ethnic Pastoral Leadership

Celebrating thirty-eight years of educational ministry (1982-2020) Theological Education Scholarship Program A partner in "training Christ's followers in skilled servant work." Ephesians 4:12 (The Message)

### A Brief History: (this was taken directly from the task force report)

In 1979, a task force was convened by Mr. George McDonald. This was in response to a progress report made to the Synod in 1980 (1980 minutes, page 121). Pastors, seminary staff and students, ethnic caucuses and Presbytery candidate(s) committee chairpersons took part in this survey. There were other groups also included in this survey. **Findings included:** 1) most ethnic minority church pastors are overworked and underpaid which consequently leads to not functioning as a good vocational role model. Despite full education preparation the pastor often is not perceived by young people to be on a par with other professionals, 2) our church does not adequately emphasize and underscore the need for ethnic pastoral leadership. This is true at the present time. There is also insufficient concern evident about the increasing need for qualified ethnic minority leadership in the future, 3) there is no functional entity with a clear responsibility for the enlistment of ethnic leadership within the Synod or in any of the Presbyteries. **Task force recommendations:** (also taken directly from the report)

- 1 That the Synod commit itself to encourage and coordinate Presbytery efforts in developing and strengthening ethnic pastoral leadership. This responsibility should be assigned to a committee formed by and accountable to the Leadership and Education Support Commission.
- 2 That vigorous programs be developed for the enlightenment of ethnic candidates for the ministry and other leadership positions. Programs of enlistment should be included in campy and conferences as well as in local church and Presbytery career days.
- 3 That the Presbyteries and Synod develop a program of seminary scholarship assistance for ethnic candidates.
- 4 That Synod prepare attractive and effective resources including audio-visual and printed materials in order to create a positive image of the ethnic church leadership, to aid in the enlistment of ethnic candidates, and to develop a support base for ethnic church leadership.
- 5 That Synod-wide support for ethnic persons presently in seminary be enhanced through a more creative use of Seminary Sunday and through visits to the ethnic ministry candidates in seminary by representatives of sessions, Presbyteries and Synod.
- 6 That Presbyteries be encouraged to develop special internship opportunities for ethnic minority seminarians to prepare them for the work of the church.
- 7 That Synod General Council annually (page cut off) .... To review the status and ongoing support ethnic pastoral leadership development with the Synod... (page cut off)
- 8 That the Synod General Council study, and when appropriate, recommend implementation of the Vocation Agency Special Report (F) entiled "Racial/Ethnic Professional Church Leadership – the United Presbyterian Church (USA)" to be presented to the 193<sup>rd</sup> General Assembly at Houston, Texas.

The Synod Assembly approved the REPL program in 1982. The initial funds for the program were provide by contribution from the existing racial ethnic caucuses and from the Synod. The funds were subsequently invested with the Presbyterian Foundation as a Permanent Fund with only interest and principal above \$80,000 to be used for scholarships. The initial individual scholarship in 1983 was \$200.00. Today we offer scholarships up to \$10,000 for highly qualified student applicants. **Find REPL on the synod.org website.**

<u>FEBRUARY 1:</u> Predominant discussion on the Climate Crisis, the involvement and possible involvement of JPIC members and congregations on this issue, along with guidance and statements from the National Church. Report on the 10th Anniversary Conference in Bethlehem of the <u>Kairos Palestine</u> document, issued by major ecumenical Christian leaders re: the ongoing and worsening situation facing the indigenous people (Muslim and Christian) of the Holy Land, attended by Rev. Meyers.

<u>MAY 9:</u> JPIC-SY was divided into three 'classes.' Continued discussion re: the Climate Crisis and how best to work with congregations and presbyteries, especially given the meeting conditions under COVID19. Considered the appeal from the Israel/Palestine Mission Network of the UPUSA re: President Trump's "Peace Plan" and the appeal to reject from the human rights-oriented Bethlehem Bible College. Discussion also over a prospective overture to General Assembly favoring a peace treaty favoring a peace treaty between North and South Korea.

OCTOBER 31: Discussion re: energy upgrade, reducing carbon and related environmental issues. Possibilities, during this pandemic, of reaching out to the area's various Farmers Markets. Focus on an "Urgent Letter" appeal sent out widely on July 1 by leading Palestinian Christians, including the increasing loss of land in Bethlehem. Much discussion on how best -- given current circumstances -- to approach re: the Climate Crisis our pastors and congregations A possible regional 'Conference' is considered. Discussion on this matter and how best to work through especially Synod channels will be a major theme at our next JPIC meeting on January 16, 2021.

## **Executive Report to Synod Assembly December**

5, 2020

I heard someone recently refer to this year as a year of losses. Perhaps it is so. We have experienced many losses. Loss of over 250,000 lives in the U.S. alone from COVID-19, loss of employment, loss of dwelling, loss of long-held businesses, loss of stability, loss of innocent lives due to systemic injustices, the list of losses continues. On a personal level, I lost my 82-year old brother in June to COPD complications.

The Pandemic has caused havoc in our lives. The virus is not discriminatory. It has affected virtually everyone on earth and has held us captive for months. All we can do is to wait for the vaccine or an effective treatment while doing our best to ward it off by wearing facial covering and keeping social distance. Unfortunately, both are not being practiced by all.

The church has not been immune to the Pandemic. As we know it, the church, a community of gathering, sharing, and worshipping body has been turned upside down where we have been forced to remain connected in different ways that we could never have imagined.

At the same time, we have realized that Christ's work for His church continues. Our congregations are mustering all their creative juices to conduct worship, Bible studies, and fellowship virtually, whether via live streaming, Zoom, or using available social network platforms. Congregations are continuing to call and install their pastors, and our Presbyteries are continuing their work, including ordaining new leaders and conducting their regularly scheduled meetings. We are sharing the communion, albeit more creatively. God's people have been faithful.

We have discovered that the Zoom app, which has been around since 2011, is an excellent tool as we gather for various purposes. I have been a part of hundreds of Zoom meetings since the Pandemic began and have come to experience firsthand what is known as Zoom fatigue. Many are expecting that this method of gathering will continue even when the Pandemic is over.

We even held our biennial General Assembly via Zoom to conduct what many considered essential church businesses, including electing the first Indigenous person, RE Elona Street-Stewart, a Synod Exec from Synod of Lakes and Prairie, as a co- Moderator. The Synod was able to provide an orientation for the General Assembly Commissioners representing our Presbyteries and also offered a Zoom venue for those who wished to have a time of debriefing after the completion of the GA.

We witnessed leadership change at San Fernando. Its long-time Executive Presbyter, Rev Ken Baker, retired as of June, and Rev. Juan Sarmiento has been called to follow in his footsteps. We also are saying farewell to Rev. Michael Mudgett, the EP of San Diego, who will retire in January. Ken and Michael have been faithful partners with the Synod, and we thank them sincerely as we wish them a blissfully blessed retirement.

The COA decided to allocate \$150,000 to each of our seven Presbyteries for COVID- related needs to assist their ministry with the member congregations. I am proud to

report that we are the only Synod to make such a large-scale grants available. Since the distribution, I have received numerous emails and handwritten cards from congregation leaders expressing their

deep gratitude for our action. I believe the COA's wise decision further bolstered our firm belief that we are indeed a connected church.

As the life of hellos and farewells continues, we come to bid farewell to Fried Wilson, who has been such an integral part of the Synod as he is to begin a new chapter in his life called retirement. Although we wish him the best, we will genuinely miss his work and institutional knowledge of the Synod that only came from his long years of service with the Synod. As we say farewell, we say hello to Paula Mann, a member of Presbytery of the Pacific. She brings her own set of skills and knowledge that will benefit the work of the Synod. We thank God for both servants, and I ask you to keep them in your prayers.

Is this the year of losses? Perhaps, but as the time of Thanksgiving approaches (as I write this report), I am reminded by the words of Habakkuk in chapter 3:17-18,

Though the fig tree does not bud and there are no grapes on the vines, though the olive crop fails and the fields produce no food, though there are no sheep in the pen and no cattle in the stalls, yet I will rejoice in the LORD, I will be joyful in God my Savior.

I pray that our faith will lead us to confess a similar prayer as we finish this extraordinary year

Report of Monte Vista Grove Homes







Every year, Monte Vista Grove Homes (MVGH) holds a fundraising gala. It's our biggest annual event, and we excitedly plan for months to honor our annual Spirit Awardees, celebrate our history, and raise funds to support our mission. The event usually includes silent and live auctions, a 4 course dinner in a lovely ballroom, and about 200 guests in evening wear. Then came COVID-19.

Rather than put a square peg in a round hole, we decided to save all the plans we'd already made for a live event - theme, centerpieces, honorees and all - and start from scratch to create a virtual experience, designing each element with the new format in mind.

Recognizing that the pandemic that caused us to go virtual had also caused a nation to spend most of the year at home, and that Monte Vista is a residential community, and all our guests would be tuning in from their own homes -- we themed the event "The Virtual Grove Gala: From our Home to Yours."

After a great deal of planning, September 12th finally came, and we debuted our first ever Virtual Gala! Longtime KNBC Weathercaster Fritz Coleman co-hosted the hour-long program with our CEO Deborah Herbert, and they made a fantastic team with great on-air chemistry. Together, they spoke to the extra financial need created by Covid-19 and recognized donors by name in real time as contributions rolled in.

The live program was interspersed with spotlight videos: MVGH Staff across all departments answered questions such as "How is your department protecting residents during the pandemic?" and "What's one word to describe Monte Vista Grove residents?" and "What are you grateful for?" Family members of our residents also provided moving testimonial videos about the care their

and silent auction item bids jumped. Our incredible supporters tuned in and gave generously to support our mission to protect and provide for senior adults, which has become more vital during this pandemic than ever before. The event had 272 registered guests, and the YouTube video has now been viewed almost 630 times. The event was planned in about 2 months, lasted 1 hour, and raised \$145,522: a success by any measure!

It took a village to pull this off, or rather, a community, and we are so deeply thankful. Trustee and Gala Committee Chairwoman. Janet Wells, spent weeks voluntarily transforming herself into a virtual event expert, and designing the hour-long program with artful precision. Fellow Trustee and Gala Committee member, Janet Louie, organized and uploaded the entire silent auction. The Board of Trustees and our Gala Committee solicited silent auction donations, helped to publicize the event, register attendees, and took on anything that needed to be done.

The most important ingredient in this recipe for success, though, was you. Our sponsors and supporters, everyone who watched, bid, donated, posted on social media, invited a friend, or said a prayer; everyone who spent an hour of their time with us, in their own living room, who believed in Monte Vista Grove's mission, and who gave generously to support it. #### Covid Response

Many of us can tell stories of our journey through COVID. The initial shock and panic which, over the course of the last 8 months, has turned to frustration and fatigue. This sums up the feelings here at Monte Vista Grove as well. The only difference is that, each week after our mandatory testing, the Director of Nursing and I wait anxiously for the results, breathe a sigh of relief in the moment and then, do it all over again. This repetitive wave of emotions seems to have no end in sight.



We are grateful for the first four months of the pandemic where we were COVIDfree. This gave us time and energy to pivot our programs, dining, infection control, and countless policies and procedures and adapt to the pandemic. Then, in July, we experienced four positive cases among our staff. After the initial fear and discouragement, we quickly moved into action. Two of the four cases were acquired from their second jobs and the other two were acquired from their spouses who had been exposed at their jobs. None of these cases reported MVGH as the source AND, it did not spread further than those four. We have had no new since mid-July and none of the



residents have been infected as of the writing of this article. I say that because this awful virus has a way of creeping in the cracks despite everyone's best efforts.



Because we are located in L.A. County, we are required to test 100% of staff and 10% of our assisted living and skilled nursing residents; a cost of approximately \$11k a week! The California Dept. of Public Health and Pasadena Dept. of Public Health both visit our campus on a regular basis to ensure that we are in compliance with city, county, state and federal pandemic mandates. Thus far, we have not received any deficiencies. We are also submitting a total of 7 different reports, some daily, some weekly, to various regulatory agencies.



We are grateful for our dedicated staff who continue to forego vacations and take on extra responsibilities and shifts. Early on, the staff made a commitment to take care of residents without the assistance of using registry or other outside caregivers. This has limited the chances of COVID entering our campus significantly! The Pasadena Dept. of Public Health has shared that they use our facility as an example in meetings and with other facilities.



Our biggest concern, next to keeping the virus out, is combatting resident isolation. This can be almost as much of a health hazard as the virus itself. To help prevent this while still maintaining compliance with the various health departments, we purchased two "visitation booths." These Plexiglas booths provide a safe way for the residents in assisted living and skilled nursing to visit with family and friends. The joy of these visits is almost tangible!



As we Zoom our way into 2021 and look forward to the future, we pray for the best and plan for the worst. You can join staff, trustees and residents in collective prayer at 12 noon and 7pm (adds up to 19 as in COVID-19), for our world, nation, state, county and city during this challenging time. We know that "this, too, shall pass" and, we will be proud of how we weathered the storm.

#### Campus Life During Covid-19

We all know the saying, "when life gives you lemons, make lemonade." When the entire campus was thrown into lockdown in mid-March due to Covid-19, we needed to re-frame and re-think our reality here at MVGH, and figure out how to "make lemonade" while keeping everyone safe.

Some of the ways in which we have adjusted have been planning specially delivered treats and meals, like Ice Cream Day, Corn Dogs and Lemonade Day, Cowboy Cook-Out and Welcome Fall Meal. For these special meals, all the golf carts are decorated, the staff dresses up, and theme music is played as we deliver these treats door-to-door. We are also delivering 'Wine 'n Nibbles' to residents on the 1st and 3rd Friday of every month, in lieu of our typical gathering.

To help keep our independent campus residents fit, members of our Wellness Committee devised an exercise circuit that encompasses the entire campus, with signs listing specific exercises to do at each stop along a half mile course, and a socially distanced outdoor stretching class meets weekly on a shaded lawn.

In The Hearth (assisted living) and Health Center (skilled nursing), the staff is using iPads to help residents connect with families via Zoom and FaceTime. We also have two Plexiglas Visitation booths that allow residents to safely see and talk to their loved ones.

We have had support from outside groups such as Girl Scouts and church youth groups, who send cards and letters of encouragement to residents.

Even though these are strange and trying times, and masks have become a "fashion statement," the residents and staff at Monte Vista Grove remain resilient, and know that "this too shall pass."

#### Join the Founders Circle

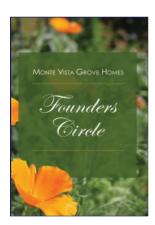

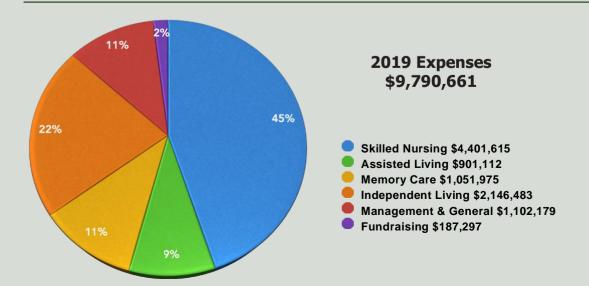


## 2019 Annual Report

2019 seems almost irrelevant given the changes and challenges brought on by the 2020 pandemic; however, it is important to note that there was an 28% increase in Revenues as compared to 2018. This was primarily due to an increase in Public Support. This was enhanced by only a 10% increase in expenses. The current year is impacted by the costs and lost revenues due to the COVID-19 pandemic. It is projected that by year end, we will experience a \$821,649 operating loss.
